COURSE CONTENT: The CDRS DRB Training Course is an intensive program designed to provide basic DRB training to individuals, owners, owner's reps., general contractors, construction supervisors, attorneys, companies or municipalities who are interested in using the DRB process during a construction project or for Construction ADR Specialists who are interested in serving on or chairing a DRB. All aspects of the use of a DRB will be covered including the residential construction DRB program, the small and large commercial building DRB program and the use of a DRB for large municipal construction projects such as roads, bridges, railroads, airports, etc. DRB member ethics, meeting procedures, dispute resolution procedures, contract language to be used to set up a DRB, site visits, selection and compensation of DRB members and other related issues will be covered. We will also review the Expanded DRB (EDRB) program that was developed by CDRS along with the Construction Settlement Panel that was also developed by CDRS.

GENERAL INFORMATION

1. Course size is limited. All participants must be approved by CDRS. It will be on a "first come" basis for any open spots.

3. Each participant will receive a CDRS DRB Training Manual.
4. The course will be conducted from 8:30am to 4:30pm.
